Acceptable forms of personal identity and proof of address include copies of two of the following documents: Current UK/EEA/EU Passport, Current UK Driving licence, Bank Account or Building Society Statement (from the last 3-months), Local Authority tax bill or Council Tax bill for the current year, Benefits or State pension Notification Letter, Disabled Drivers Pass, EU-EEA National Identity Card.

Please do not send us your credit card, bank or building society statement or any other document that displays the full 16 digits of your debit or credit card number. If you do, we will return your documents immediately and this may affect your eligibility for the Feed in Tariff Scheme.
